## **Privacy Notice (How We Use Visitor Information)**

This Privacy Notice for visitors explains how and why we store personal information about those who visit the school. It provides a guide to our legal obligations and their own rights. Like any organisation which handles personal data, our school is the 'Data Controller' as such, we are registered with the ICO (Information Commissioner's Office) and we comply with UK General Data Protection Regulation (UK GDPR). Our ICO registration number is ZA565715.

### **The Categories of Visitor Information That We Process Include:**

We process the following personal information from visitors –

- Visitor Name
- Visitor Organisation
- Reason for Visit
- Visitor Time and date of visit
- Visitor Car registration where applicable
- Visitor Phone Number where applicable
- Confirmation of identification
- Confirmation of reading Safeguarding / Fire Policies

### **Why We Collect and Use Visitor Information**

We use visitor data to:

- Ensure the safeguarding of young people and vulnerable adults
- Maintain high standards of health and safety
- Monitoring visitor statistics

Under the UK General Data Protection Regulation (UK GDPR), the legal basis / bases we rely on for processing personal information for general purposes are:

- (6c) A Legal obligation: the processing is necessary for us to comply with the law.
- (6e) Public task: the processing is necessary for us to perform a task in the public interest or for our official functions, and the task or function has a clear basis in law.

The lawful bases for processing personal data are set out in Article 6 of the UK General Data Protection Regulation.

### **Storing Visitor Information**

### **Who We share Visitor Information With**

We do not share visitor information with third parties unless we are legally required to do so.

### **Requesting Access to Your Personal Data**

The UK-GDPR gives you certain rights about how your information is collected and used. To make a request for your personal information, contact the school administrator or our Data Protection Officer at [DPO@SchoolPro.uk](mailto:DPO@SchoolPro.uk).

You also have the following rights:

- the right to be informed about the collection and use of your personal data – this is called 'right to be informed'.
- the right to ask us for copies of personal information we have about you – this is called 'right of access', this is also known as a subject access request, data subject access request or right of access request.
- the right to ask us to change any information you think is not accurate or complete – this is called 'right to rectification'.
- the right to ask us to delete your personal information – this is called 'right to erasure'
- the right to ask us to stop using your information – this is called 'right to restriction of processing'.
- the 'right to object to processing' of your information, in certain circumstances
- rights in relation to automated decision making and profiling.
- the right to withdraw consent at any time (where relevant).
- the right to complain to the Information Commissioner if you feel we have not used your information in the right way.

There are legitimate reasons why we may refuse your information rights request, which depends on why we are processing it. For example, some rights will not apply:

- right to erasure does not apply when the lawful basis for processing is legal obligation or public task.
- right to portability does not apply when the lawful basis for processing is legal obligation, vital interests, public task or legitimate interests.
- right to object does not apply when the lawful basis for processing is contract, legal obligation or vital interests. And if the lawful basis is consent, you don't have the right to object, but you have the right to withdraw consent.

Where we process your personal data based on your consent, you have the right to withdraw that consent at any time.

To request the withdrawal of your consent, please contact the Trust Data Manager at [admin@croftymat.org](mailto:admin@croftymat.org). We will respond to your request promptly and ensure that your data is no longer processed on the basis of consent, unless another lawful basis applies.

Under Section 164A of the Data Protection Act 2018, you have a statutory right to complain if you believe your personal data has been handled inappropriately.

If you wish to raise a concern about how we process your personal data, please contact us directly at [dpo@croftymat.org](mailto:dpo@croftymat.org). We will acknowledge your complaint within 30 days of receipt and take appropriate steps to investigate and respond without undue delay.
